**Discussion:** Todd states that the process should include someone reviewing the DM Job Description with Will, make the offer and see if they can come to an agreement on Salary.

<u>Motion 5:</u> Move to Authorize the Chair Ken Masten, Acting District Manager, to offer Will Natividad the KSWCD District Manager position. Motion allows Ken to go into salary negotiations beginning rate \$27/hour, first review at the end of 3 months with possible pay increase at that time. Three-month time period to begin when/if job offer is accepted.

**Discussion:** Denise reports that there were a couple of other good candidates and the committee feels like one of them could possibly be a good fit for the open Conservation Coordinator position. Todd is hopeful that the DM would move swiftly to fill the Conservation Coordinator position.

## **Hiring Committee Report/Discussion:**

David reports that the District received 11 applications. The Hiring Committee interviewed the 2 top applicants on October 21, 2022. Each of the committee members scored both interviewees on a pre-established scoring matrix. The committee met separately prior to this morning's meeting to discuss the results of the interviews and have arrived at a recommendation for the Board.

The committee recommends the Board make an offer to Will Natividad for the KSWCD District Manager position.

Todd's opinion is that the Acting DM should be the one to make the offer.

Salary recommendation is to start at \$27/hr. for 3 months then have a review.
